Minimum loan amount is \$5,000. The interest rate applied may be up to 2.5% higher based on the applicants credit score, debt ratio or vehicle value. HRCU makes all final determinations regarding the vehicle value and applied interest rate. See the LOANLINER Credit and Security Agreements available from the credit union.



# ANNUAL MEETING NOTICE

In accordance with the Credit Union's bylaws, the President of the Board shall appoint a nominating committee at least 30 days prior to the Annual Meeting. It shall be the duty of the nominating Committee at the Annual Meeting to nominate one or more members for each vacancy for which elections are being held. After the nominations of the committee have been placed before the members, the presiding officer shall call for nominations from the floor.

The election shall be conducted by ballot, except where there is only one nominee for the office. All elections shall be by plurality vote. The nominating committee was appointed at the December 2018 Board Meeting. In 2019, two board positions will be available. George Zwiebel and Mary Ellen Setlock are current members of the Board of Directors and are running for re-election.

The Annual Meeting is a credit union tradition — one you likely won't experience at a stock-held financial institution. It's one of the many benefits of belonging to HRCU – we hope to see you there!
